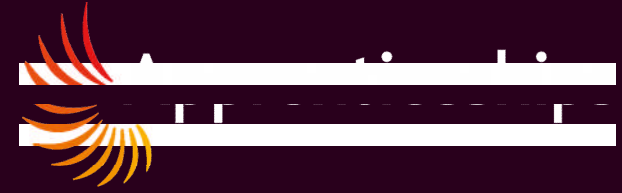

# Apprenticeship Grants for Employers for 16 and 17 year olds

- £2,500 Incentive for Employers taking on new Apprentices
- 5,000 grants nationally with 400 in the East Midlands
- Unemployed young people 16 and 17 years old
- Available now until 31<sup>st</sup> March 2010
- Grant administered by NAS

# Apprenticeship Grants to Employers - Process

- Provider finds employer vacancy



- Provider emails NAS for approval at [agegrant@lsc.gov.uk](mailto:agegrant@lsc.gov.uk)



- Approval code sent to provider



- Provider fills vacancy with eligible young person



# Apprenticeship Grant to Employers-Process cont:

- Candidate recruited and ILR and contract of employment signed
- ↓
- Provider completes claim form detailing NAS authorisation code, employer, apprentice name and ILR start date and ILR learner number and submits to NAS
- ↓
- ILR field A46 and Special Project Code 116 (ILR to start before 31<sup>st</sup> March 2010)
- ↓
- £2,500 to provider

# Apprenticeship Grant to Employers-Process cont:

- Provider pays employer
  - £1,500 on start
  - £1,000 after 12 weeks

- 16-18 in conjunction with LA's
- 19+ providers in conjunction with SFA and EMDA

# Apprenticeship Commissioning Process 10/11

Reflecting National and Regional sector priorities

- SSD to National NAS moderation by Jan 2010
- 16-18 growth to YPLA Regional Planning Group, February 2010
- NAS presents SSD to SFA to detail commissioning arrangements with providers by Feb 2010
- SFA will confirm Apprenticeship allocations with providers by end of March 2010
- 10/11 – Providers allocations – Regional Residency Schedules

# Re-allocation of funds

## Quarter 1 Review

- 16-18

- Nationally needed to recover £20M to cover the costs of the GTA/ATAs
- EM recovered £2.3M
- EM approved £1.4M of business cases for new Starts (includes the EM GTA/ATA)

- 19-24

- EM recovered £629k.
- Approved business cases totalling £530k. Priority given to correcting allocations (carryover costs erroneously profiled) and NHS starts.

- 25+

- EM recovered £126k
- Approved business cases totalling £139k. Corrections to flat-profiles and
- Higher than expected carryover costs.
- Freeze on 25+ starts.

# Apprenticeship Vacancies Online

- 99% of Regional Providers have registered and completed their employer and candidate profile.
- Over 60% of Providers are regularly putting vacancies on the system
- East Midlands progress at the end of December 2009:-
  - 900 plus employers have posted a vacancy
  - 2225 Vacancies have been posted
  - 19315 Candidates have registered
  - 12575 Candidate applications had been made
  - 80% of Candidates are aged 16-24
  - 444 Candidates successful (many more in the pipeline)
