Employability of the unemployed and economically inactive to enter Pu



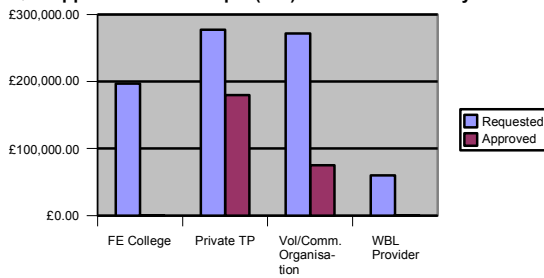
